ALL BOATS MUST BE WIND-POWERED ONLY ... Let your imagination run wild ... All children under 15 years old on boats **MUST** wear life vests at all times during the race ... **Home-crafted hulls will be eligible for the "BEST IN SHOW" award !!!** Open to anyone in a "wind-powered boat" provided this Entry Form has been completed, signed and submitted to the Regatta officials prior to race time.

1:30 - All "boats" gather at the balloon Starting Line at Linnie Canal and Grand Canal. Regatta entries (REQUIRED) must be handed to the Race Committee prior to the start (see Regatta Entry Form below).

1:45 - Start of the Kids Division ... Ages 14 and under.

2:00 - Start of the Adult Division .. All those 15 and older.

A blast from a fog horn will start each of the races. Regatta Officials will note the winning boats as they cross the balloon Finish Line at Eastern Canal & Linnie Canal ... the first 3 boats to finish in each division will receive trophies.

RACE ENTRY AGREEMENT - Please Read Carefully

If you do not agree to these conditions, you must not participate in this activity. All individuals under 18 must have this form signed by their parent or legal guardian.

In consideration of acceptance of my/our entry by the Venice Canals Association ("VCA") in the July 4th 2010 Linnie Canal Downwind Regatta ("the Activity"), I/we acknowledge and agree as follows:

1. Designing, building, and racing my/our vessel in the Activity is at my/our own risk and I/we undertake the Activity of my/our own free will and am/are responsible for my/our own safety. I/we understand the Activity will not be supervised by any trained lifeguards or safety officers. Those individuals who have volunteered to assist in the Activity will take no action to mitigate these natural risks, & offer no guarantee of safety.
2. I/we understand children on boats **MUST WEAR** life vests during the Activity.

3. ASSUMPTION OF RISK. THERE ARE RISKS INHERENT IN THE ACTIVITY, AND I/WE FREELY ASSUME ALL RISKS, INCLUDING PERSONAL INJURY OR DEATH TO MYSELF AND MY CREW, LOSS OR DAMAGE TO MY VESSEL AND ITS EQUIPMENT, AS WELL AS UNFORESEEN RISKS.

4. WAIVER, RELEASE AND INDEMNIFICATION. TO THE FULLEST EXTENT PERMITTED BY LAW, I/WE WAIVE ALL CLAIMS, FOREVER RELEASE AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE VCA, IT'S MEMBERSHIP, AND BOARD OF DIRECTORS, AS WELL AS ALL KNOWN AND UNKNOWN SPONSORS OF THE ACTIVITY, FROM LIABILITY FOR ANY AND ALL INJURY ARISING FROM MY/OUR PARTICIPATION IN THE ACTIVITY.
